MPCI Notice of Claim Requirements

Notice of Claim is required to be submitted within 72 hours after discovery of damage, but not later than 15 days after the end of the insurance period, which is **the earlier of** the harvest date of the unit or the calendar date listed below:

New 2012 Application Form

RMA has added several items that must be answered when submitting a new or renewal application. Please be sure to use the 2012 form available in E-Commerce Forms on the AFBIS home page. This will avoid the inconvenience of contacting your producer for another signature.

Named Insured

Please ask your insureds "Do you do business by any other name?" when reviewing the person type and verifying the SSN/EIN. The name on the policy should be the name used when certifying at the FSA and/or selling commodities.

Forage Production Reports and Acreage Reports

for **ND, SD, MT and WY** are due 10-16

Rye Production Reports and Acreage Reports

for **ND and SD** are due 10-31



Spring Premium Billing

Billings for MPCl premium due October 1 will be mailed October 5. **This is the first billing.**

Agents should access the "Policy Due List" after logging into the AFBIS, Inc. web site. (www.afbisinc.com).

If an insured brings a premium payment to your office it must be mailed to Fargo. The check should be payable to AFBIS, Inc. If you have any questions about unpaid premium, please call the Fargo office.

2012 FALL WHEAT/BARLEY Production and Acreage Reports

Missouri

The Production Reports are due 11/14.

The Acreage Reports are due 11/30 and were mailed to agents in early September.

FALL DEADLINE REMINDER

November 14, 2011 is the deadline for Production Reports. November 15, 2011 is the deadline for Acreage Reports for **Wheat** in most states, **Rye** and **Forage Production** in all states except ND, SD, MT and WY. Forms must be received within 10 days of the deadline.

** ATTENTION **

Agents in every state are required to keep signed documentation for all forms when information is submitted via the web – agents agree to this in writing when they accept the web procedure.

Broadcast Seeding

Reminder: If required by county actuarial Special Provisions, any acreage seeded in this manner **MUST** be inspected to be insurable for 2012.



Agent Book of Business

View your MPCl and Crop Hail policy information, incoming/outgoing paperwork, premiums paid/unpaid, active policyholders, claims information via the internet at www.afbisinc.com. Click on Agents: enter **your** USERID and PASSWORD: and click on View Policies. APH, Acreage and Notice of Claim can also be submitted via your book of business.

If you have forgotten your ID and/or Password, check the "E-mail forgotten User ID and Password" to have it sent to your e-mail.

Web Based Claim Notices

Submitting a claim notice over the web is fast and easy. After you login to the afbisinc.com website, click on "Policy Information". Bring up your policies and select "Notice of Claim" from the pull down menu on the left. Please contact our Support Department if you have any problems at 800-662-5142 ext.6919.

Help Our Adjusters!

Please enter the cell phone number of the insured on the Notice of Claim. This will assist our adjusters when contacting the insured.

APH Tips for Agents

1. Please be certain all farms planted in 2011 have production reported.
2. When adding a farm, please list the legal location, FSN, any production history or indicate "added land" if applicable, and full share name.
3. FSN or legal description *change* must be noted at this time. All FSN's listed as "1" must be updated.
4. If the insured is a **New Producer**, please indicate on the Production Report.
5. THE INSURED AND AGENT MUST SIGN AND DATE THE FORM.
6. Past years production can be reported, as long as it is reported continuously.
7. **Production divided by acres equals the yield. Please check all calculations!!**
8. Report Full Share Name.



*If your insured is a **NEW APPLICANT**, the insured and agent must complete a blank Production and Yield worksheet by the applicable deadline.

*If the insured is a **TRANSFER** from another company, we must have the 2011 Production completed on a blank Production Report.

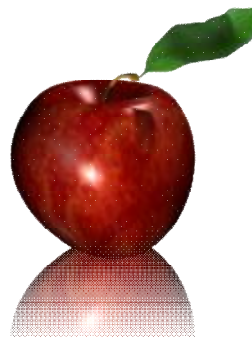
